Trustees Annual Report for the year 2018-2019

This is an abridged version. The full Report is on the Members' Section of the web-site.

Review of Activities and Achievements

The financial year saw the Museum consolidate its activities after an eventful prior year, and it resulted in an excellent year for events bringing in a small but welcome improved attendance of 2% over the previous year. With an active Marketing and Events Team, several new attractions were introduced including a visiting Great Western Railway locomotive, this proving attractive to Railex participants in particular and if possible will be repeated in the future.

In the meantime, it was realised that due to inordinate delays by the Planning authorities, and continuous rainy weather prohibiting any groundworks, no progress could be made on the plans for the proposed new workshops and restoration shed alterations. In any event, re-appraisal showed serious flaws in the original concept for the scheme from the demographic and financial aspects, and the planning consent floundered in September 2019.

New thoughts were being considered, particularly in view of the temporary planning permission for the BDJ Walsh Railway Heritage Centre expiring in 2021, and the necessity for a new display area within any new building to be erected. In the light of advice from the Planning Authority, the Trustees decided to employ a Planning Consultant to assist in any future planning applications, and work is currently under way to make progress in this respect. In the meantime, part of the original scheme was carried out to advantage with the construction of the 'Set-Down' area, where many of the piles of concrete sleepers and other large objects have now been stored, thus releasing more recreational space.

Restoration work and other projects have continued, notably with the completion of rebuild of the diesel engine of Toby the Tram Engine, and the Diesel Railbus becoming mobile, with the question of the seating being addressed. Maintenance and rebuilding of our various locos has continued, and in general it is a tribute to our engineering staff that we have had three working steam engines available for use throughout the year, and another in the throes of a major rebuild.

Work has continued on construction of the new miniature railway, with a great input from Teams Wednesday and Thursday. In general from the operational point of view, the Museum has been well served by its volunteers, but our permanent paid staff must not be forgotten and without their assistance and loyalty we would find it hard to continue. Amongst the paid staff is our Curator Adam Culling, who has put in great work to update the Museums Accession Register by the introduction of the 'Past Perfect' computer programme, and it is pleasing to report that having submitted an application for re-accreditation in 2016, Arts Council England granted us full re-Accreditation, to be next reviewed in 2023. We have been pleased to welcome volunteer assistance for the collection from Colchester Arts Council in particular, and in view of our paid work in maintaining the Archive of the National Railway Heritage Awards Trust, that organisation made a grant of £2,500 to the Museum for the employment of a student to archive the NRHA collection.

To fulfil our educational objectives, several school visits have been made, and visits by parties of members from other organisations, with several outreach talks being held, apart from the general education of the public during our various operating and non-operating days when volunteers converse with the public to explain the historic role of railways within the social fabric of society.

Review of Financial Position

The Museum combined with its Trading subsidiary enjoyed healthy revenues of £350,000, which is slightly down on last year. Our greatest revenue earners continue to be Thomas events producing contribution of £115,000, including 54 going on another adventure to Utrecht masquerading as Thomas with four Museum members to crew the engine. The Winter 19 Beer Festival was considerably warmer than the previous year and this, along with the Summer Beer Festival produced a fine contribution. Facilities hire continues to do well, generating £32,000 for the Museum and we are looking to increase this revenue stream.

Our biggest outlay is for our 9 employees who have all served the Museum very well at a cost of £110,000 to keep the Museum open all year round, and looking presentable for visitors. They were assisted by the Marketing Manager who helped with the publicity and producing several good revenue earning events.

There are various projects on the go and completed. The North Signal Box had some major surgery costing £6,700. At the start of the year the set aside area in the corner of the yard was completed requiring another £4,500. The Miniature Railway has made major progress with a further £10.000 being invested, the results are out there for all to see. And also, well underway, is the Running Shed with £32,000 invested during the year to 30th September 2019.

What we have achieved thanks to all you volunteers is absolutely tremendous, and we Trustees are greatly assisted by the excellent team of Heads of Departments. In short, our financial position is healthy and long may it continue.

Membership and Museum Visitor Attendance

One of the problems shared by the Museum and other similar organisations is that of getting new members, particularly from the younger age groups, and whilst we have young men and women joining the engineering teams, few if any are interested in the administrative aspects of Museum work, giving a cause for concern over succession.

We have had many mature members join us, particularly after having taken part in a 'Railex' day, and others have joined the Teams Wednesday and Thursday not only giving us the use of their skills, but enjoying the social aspects of their volunteer work. Visitor attendance during the year in question has been good, with an improvement on the previous year due mainly to a preponderance not only of good weather, but also attractive events. Days out with Thomas have been a major source of income for the Museum, as have the Beer Festivals run in conjunction with CAMRA.

Long Term Proposals

The Trustees have a serious task on hand to firm up the proposals for the new building and improvements to the existing Restoration Shed, decisions which must be taken to cope with the situation of location of the Heritage Centre exhibits when the temporary planning permission expires in 2021. Additionally there is the erection and use of the proposed Running Shed, and together with the additional task of re-erection of the Chelmsford Water Tower there is the question of urgent repairs and renovation needed to the main station building. With a diminishing work force, new blood is needed on the Board of Trustees and the recent benefits of a professional curator have demonstrated the need for additional staff on the curatorial team. Some of these requirements may be met from grant aid, but others from revenue income for which effort is required to ensure the running of successful money earning events.
